PRIVACY POLICY

The purpose of this Privacy Policy ("Policy") is to inform you about how LA MARTINETTE collects and processes your personal data when you use our online services, sign up for our newsletter on our website or when you visit our winery, create an account on our website or place an order online. This Policy is also intended to inform you of your rights regarding your personal data. It is therefore important that you read this Policy and any other specific information we may provide to you from time to time when we collect and process your personal data.

The data controller

The company SCEA LA MARTINETTE, a non-trading agricultural company with a capital of 72,356. 866.13 euros, registered in the Draguignan Trade and Companies Register under number 499 663 300, whose registered office is located at 4005 chemin de la Martinette - 83510 LORGUES, hereinafter referred to as "LA MARTINETTE", is the data controller within the meaning of the regulations applicable to personal data, and in particular Law No. 78-17 of 6 January 1978, known as the "Data Protection Act", and EU Regulation 2016/679 of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data ("RGPD"). In this Policy, the terms "we", "us", "our" refer to LA MARTINETTE.

The origins of the collection of your personal data

The sources of collection of your personal data are:

- The contact form that you can fill in when you visit our shop;
- The contact form that you can fill in online to receive our newsletter;
- The creation of your online account;
- The purchases you make online on our site.

The personal data we collect

In the course of providing its services, LA MARTINETTE collects and processes the following categories of personal data about you

- Identification data, such as your first name, last name and password;
- Login information, when you log in to your account;
- Contact data (billing and delivery data, if different), such as your email and postal addresses and telephone number;
- Transaction and order tracking data, when you make online purchases (order information, description of products purchased, quantities, amounts, payment
 methods, possible application of discounts or promotional offers).

This data is collected according to the LA MARTINETTE services you use and for the purposes described in Article 4 below.

Where we are required to collect personal data from you (pursuant to a legal obligation or a contract we have entered into with you, or intend to enter into with you, such as in the context of an online purchase and sale) and you do not provide such personal data when requested, we may not be able to provide you with the services you require. The mandatory nature of the data is indicated at the time of collection by an asterisk.

The purposes of processing personal data

The purpose of the processing corresponds to the objective pursued by the use of your personal data. LA MARTINETTE collects and processes your personal data in order to:

- Allow you to create an account on our site, to access and manage your account;
- Send you our newsletter;
- Process and manage the orders you place online;
- Respond to your requests to exercise your rights.

The legal basis for processing your personal data

We collect and process your personal data when:

- The processing of your personal data is necessary for the performance of the contractual relationship between you and us, such as in the context of the management of the orders you place online;
- Processing is necessary to comply with a legal obligation to which we are subject, for example in the context of product recall or withdrawal procedures or for the accounting processing of your orders;

Processing is necessary for the pursuit of our legitimate interests, for example when we send you marketing emails about

- The processing is necessary to pursue our legitimate interests, in particular when we send you marketing emails about the same or similar products to those you have previously ordered online;
- · You have given your consent, in particular for the sending of our newsletter.

The recipients of your personal data

In order to provide our services, we may communicate your personal data internally to a limited number of people and departments authorised to have access to it and transmit or give access to your personal data for technical, logistical or commercial reasons to our hosting provider, development and maintenance of our site, our service provider in charge of sending the newsletter and commercial prospecting, our service provider in charge of the development and maintenance of the customer relationship management platform, as well as to payment service partners and carriers in charge of delivering orders placed online.

LA MARTINETTE may also disclose your personal data to third parties when such disclosure is required by law, regulation or court order, or if such disclosure is necessary to protect and defend its rights.

Data transfers outside the EEA

LA MARTINETTE ensures that no transfer of personal data to a country outside the European Economic Area (EEA) is made by LA MARTINETTE or its partners or subcontractors in the absence of an adequacy decision by the European Commission or the implementation of appropriate and adequate safeguards to ensure the security and protection of your personal data, such as the European Commission's standard contractual clauses.

How long your personal data is kept

Your personal data is retained by LA MARTINETTE for the time necessary to fulfill the purposes for which it was collected.

In determining the appropriate retention period for your personal data, we consider the amount, nature and sensitivity of the personal data, the potential risk resulting from unauthorised use or disclosure of the personal data, the purposes for which we process your personal data and our legal obligations. Please note that for the purpose of sending marketing emails, LA MARTINETTE will only retain your personal data for a period of 3 years after your last interaction with LA MARTINETTE. To meet our tax and accounting obligations, we retain personal data of a transactional nature (and associated identification and contact data to the extent required for these purposes) for the statutory limitation period after an individual ceases to be a customer. During the period in which we retain your personal data, LA MARTINETTE takes all necessary and appropriate steps to ensure the confidentiality and security of your personal data, against any risk of deletion, alteration of such data, or access by unauthorised third parties.

Your rights

Depending on your personal situation, you have the rights listed below in application of the RGPD and the Data Protection Act.

Right of access: You have the right to obtain confirmation that we are processing personal data about you. Where applicable, you have the right to access the personal data we hold about you. This gives you the right to receive a copy of your personal data and certain information about the processing of your personal data.

Right to rectification: You have the right to ask us to correct your personal data if it is inaccurate or out of date. If you have created an online profile, you can correct your information at any time by visiting your account.

Right to erasure: In certain circumstances, you have the right to request the erasure of your personal data. Please note that your personal data can only be deleted when it is no longer necessary for the purposes for which it was collected and we have no other legal basis for processing it.

Right of limitation: You may request that we restrict the use of your personal data in certain circumstances, such as where the data is not or is no longer required, or where you have challenged the accuracy of the data, until we can verify its accuracy.

Right to portability: We will provide your personal data to you, or to a third party chosen by you, in a structured, commonly used and machine-readable format. Please note that this right only applies to your personal data that we process automatically (i) with your consent or (ii) in the performance of a contract with you.

Right to object: Where we process your personal data on the basis of a legitimate interest, you may object to such processing where your particular circumstances justify it. In some cases, we may not comply with your request if we demonstrate that the legitimate interest we are pursuing prevails. You also have the right to object to the processing of your personal data for direct marketing purposes at any time and without justification.

Withdrawing your consent: If the processing of your personal data is based on your consent, you have the right to withdraw it at any time. In particular, if you wish to unsubscribe from any mailing list (newsletters, commercial prospecting) at any time, you can do so by clicking on the link at the bottom of all our communications. Fate of data after death: You can also formulate directives concerning the conservation, deletion and communication of your personal data after your death. You will not be charged a fee to access your personal data or to exercise any of the other rights mentioned above. However, we may charge a reasonable fee if your request is manifestly unfounded, repetitive or excessive. We may also refuse to comply with your request in these circumstances. We may ask you for specific information to help us confirm your identity so that we can respond to your request to exercise one of your rights. We try to respond to all legitimate requests within one month. Sometimes it may take longer than a month if your request is particularly complex or if you have made a number of requests. In this case, we will inform you and keep you informed of the progress of your request.

In addition, organisational measures (such as security clearance systems for data access etc.) are in place to safeguard the confidentiality of your personal data. For example, access to your personal data is strictly limited to our staff, who are expressly authorised, and to our partners and subcontractors, who are themselves acting on our instructions and in accordance with our contractual terms and applicable law.
